Conference Attendance Award 2014

What is the Conference Attendance Award?

The aim of this award is to promote professionals with less than 7 years work experience in the NSW local government water and sewer industry. The Water Directorate established this award in 2004 in conjunction with the Australian Water Association.

What is the prize?

The winner of the Conference Attendance Award will attend Ozwater'14 in Brisbane, 29 April – 1 May 2014. The Australian Water Association provides one full registration gratis to the successful applicant valued at up to \$1,690 and the Water Directorate covers the cost of travel and accommodation up to the value of \$1,600 (excl GST). In addition, the Water Directorate covers the cost of attending the AWA Young Water Professionals Workshop and Breakfast.

Please note that copies of all travel and accommodation receipts must be submitted to the Water Directorate for reimbursement. Any costs above \$1,600 will need to be paid by the winner or his/her employer.

What is Ozwater '14?

Ozwater is an event like no other, organised by the water industry where issues that drive the water industry are discussed and future directions decided.

The Ozwater'14 Conference will feature inspirational international and national keynote speakers, numerous invited speakers, scientific and technical papers, case studies, workshops and poster sessions.

Ozwater'14 is being held at the Brisbane Convention and Exhibition Centre, from 7–9 May 2014. Visit the Ozwater'14 website at www.ozwater.org for more information.

Who is eligible for this award?

To be eligible nominees must be working for a Water Directorate member council in a water and sewerage section of council and have less than 7 years professional experience in the water industry. Nominations from final year graduates that are planning to work in the local government water and sewer industry are also welcome.

How do I nominate?

The nomination form should be completed by the applicant and signed by his/her manager. It should then be faxed to 02 8267 3071 or emailed to estanley@waterdirectorate.asn.au. Attendance must be in accordance with the normal policies and procedures for leave at the applicant's Council. Nominations are due by close of business on Friday 28 March 2014. The winner will be notified by Friday 4 April 2014.

What is required from the winner?

A brief report (max 500 words) on the benefits received from attending Ozwater'14 should be submitted to the Water Directorate Executive Committee by 30 June 2014. The successful applicant is also expected to attend Young Water Professionals networking events as listed on the Conference program.

How will the nominations be judged?

All nomination forms are judged by the Executive Officer and the Chair of the Water Subcommittee. Judging criteria is based on the engineering and environmental benefits to council as well as the professional benefits that are received from attending Ozwater'14.
